- The company will provide 3 months of free support and maintenance.

7. Project Timeline

- Estimated time for the application development typically ranges from 1-2 months.
- Delays due to client-side actions (e.g., content delays, feedback delays, or required additional features) will extend the timeline.

8. Revisions and Modifications

- For game development, revisions are typically limited to functionality, user interface, and gameplay mechanics. Major changes in game design or new feature requests after delivery may be treated as a new development request.

- A 30-day warranty period is provided after game deployment to fix any bugs or issues that arise.
- After the warranty period, ongoing maintenance and updates can be provided for an additional fee as per the agreement.
- We will offer support for issues related to bugs and functionality but do not cover any external issues related to app store approvals or third-party services.

13. Payment and Refund Policy
